### **PLEASE READ AND SIGN THESE TERMS AND CONDITIONS TO BE RETURNED WITH TRADE SITE APPLICATION FORMS**

1. All trade sites must be set up before the gates open to the general public on the day of the show, all vehicles will need to be removed from trade site area and parked in a designated parking area unless pre organized with the show committee. Gates will open at 9am, a member of the show will be on site from 7am to direct you to your allocated sites, NO trade sites will be moved or rearranged on show day.
2. All trade sites must conform with OH&S rules and regulations, traders are asked to have all electrical equipment and leads tested and tagged prior to the opening of the show, any equipment which fails this will be asked to be removed from the grounds.
3. Applicants must state the full size of their trade stand in their application, additional area will not be allocated on show day.
4. All stall holders must hold **a current and reputable Australian approved Public Liability Insurance**, which must be included in their application form, failure to do so will result in your application being rejected.
5. The show committee holds no responsibility for any accidents or injuries at your stall caused by the stall holders wrong doings, we are not liable for any loss or damage caused to the stall holders' persons or property. If an incident occurs at your site please proceed directly to the secretary's office and complete an incident report.
6. Sites selling food and beverages, whether consumed at or after the show must comply with all food South Australian food safety laws and provide a **CURRENT FOOD BUSINESS NOTIFICATION NUMBER**
7. Trade vendors are only permitted to sell/display products/goods which are clearly stated on their application forms and are accepted and approved by the show committee.
8. Trade vendors are not permitted to have for sale, sheath and/or pocket knives, flick knives, explosives/fireworks or stink bombs.
9. **FAILURE TO COMPLY WITH THESE TRERMS AND CONSTIONS MAY RESULT IN A STALL HOLER BEING REJECTED OR A STALL SITE BEING SHUT DOWN AND REMOVED FROM SITE, NO REFUNDS WILL BE GIVEN FOR NON-COMPLIANCE**
10. Sites are given on a first in best dressed situation as we have limited space available (especially indoors), once a booking has been accepted a refund will available of 50% up to 2 weeks prior to the show.
